

# Task 2a – Perform a full service and maintenance on vehicle 1

You must:

- i. prepare the working area to complete the full service and maintenance on vehicle 1
- ii. perform the full service and maintenance on vehicle 1 in accordance with your planning documents produced in Task 1. This should include:
  - decommissioning and inspection of the vehicle systems
  - diagnosing and recording faults within the vehicle systems, including carrying out appropriate tests and measurements
  - replacing components and consumables as required in the service schedule and any fault diagnosis
  - safely using the appropriate tools and equipment
  - recommissioning of the vehicle
  - demonstration of vehicle functionality to the manager
  - re-instating the work area
- iii. record the full service and maintenance, to include:
  - completed service sheets
  - completed job card with description of work carried out.

### Conditions of assessment:

- the time allocated for this task is 4 hours
- you must carry out the task on your own, under **controlled conditions** while being observed
- you will be given copies of your completed documentation from Task 1
- you will be given access to the internet for fault diagnostic analysers and researching fault codes.

## **Controlled conditions:**

- you must only work on your tasks in the allocated times
- assessment evidence must be handed in at the end of each session for secure storage which cannot be accessed
- all practical work areas and any evidenced produced must be kept secure and only accessible by the assessor
- you must not share or discuss your work with other candidates
- you are not permitted to bring any materials into the assessment session.

### What must be produced for marking:

- completed job card for vehicle 1
- completed manufacturer's service sheet
- internet search history for fault diagnostics and fault codes.

### Additional evidence for this task:

- assessor observations of the work area preparation.
- assessor observations of the service and maintenance activities for vehicle 1

- test equipment set up
- re-instated work area.

- copies of completed documentation from Task 1
- access to relevant information sources (digital or hard copy) for vehicle 1
- internet access for: fault diagnostic analysers and fault codes
- PPE and VPE
- working area
- access to vehicle 1 which meets the requirements of the brief
- replacement parts, materials and consumables
- appropriate tools and equipment
- measurement, fault diagnosis and test equipment
- appropriate ICT equipment and software, including manufacturer specific diagnostic testers
- access to a rolling road to demonstrate vehicle functionality.
